OFF-LICENCE

Sections 17 to 20, and 64, Sale and Supply of Alcohol Act 2012

 - i. at every point-of-sale detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
 - ii. a copy of the licence attached to the inside of the premises so as to be easily read by people entering each principal entrance to the premises; and
 - iii. a sign prominently displayed in a prominent place on the premises, which identifies by name the manager for the time being on duty;
 - iv. a copy of the Host Responsibility Policy in view of the public
- e) drinking water is to be freely available to customers, while alcohol is being supplied free as a sample at the place where the samples are being supplied
- f) no single sales of:
 - (i) beer or ready to drink (RTD) spirits in bottles, cans or containers of 500mls or less in volume may occur except for craft beer; and
 - (ii) shots or premixed shots.

REMOTE SALES

The sale of alcohol by remote sale must comply with section 59 of the Act, and requirements set in the Sale and Supply of Alcohol Regulations 2013.

THE LICENSED PREMISES

The premises is more precisely identified as outlined in a plan received by the Masterton District Licensing Committee on 29th April 2021.

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force-

- (b) if an application for the renewal of the licence is duly made before the licence expires, until the close of the period 3 years after the expiry date.

- e) drinking water is to be freely available to customers, while alcohol is being supplied free as a sample at the place where the samples are being supplied
- f) no single sales of:
 - beer or ready to drink (RTD) spirits in bottles, cans or containers of 500mls or less in volume may occur except for craft beer; and
 - (ii) shots or premixed shots.
